Season Passes Available

- Family \$750.....Includes: husband, wife, and children (includes college students)
- Single \$540.....21 years or older (based on age as of June 1, 2025)
- Couple \$615..... Includes husband and wife, or 2 adults (21 years or older) residing at the same address
- Junior \$210.....Under age 21 (based on age as of June 1, 2025)

Early Bird Special

Payments received by December 31, 2024, will be eligible for a discount on 2025 season passes. There is an increase for 2025...by paying early you can lock in the 2024 membership rates.

Golf Cart Owners

You must be a current season pass holder of Veteran’s Memorial Golf Club to store your cart on the premises. Please be advised that although efforts have been made to make the sheds as secure as possible, all items stored in the sheds are the renters’ responsibility. Private golf carts stored off the course must pay a seasonal trail fee.

Season Pass Payment Plan

You may pay your Season Pass and Cart Fees over time. Simply divide your total fees by four and include four equal checks with your application. Post-date the checks January 1st; February 1st; March 1st; and April 1st. All four postdated checks must be received by December 31, 2024, to be eligible for early bird special. Season pass fees must be paid in full prior to your first time playing golf. If the season pass fee is not paid in full your first time playing, you must pay the daily green fee rate. NO EXCEPTIONS!!

Bag Shed Lockers

Bag Shed Lockers are available for the season to store your clubs and/or rolling carts. Renters must provide their own lock. The main shed door will be unlocked during business hours and locked when the course is closed. Clubs/bags/carts/personal items are stored at your own risk.
